The **Associazione Nazionale Maestri di Ballo (ANMB)** – a Professional organization having its Head office in Modena, via P. Ascani, 44, 41126 – represented by the President, **Stefano Francia**,

and

Israeli Council for Culture and Dance Sport (ICCDs), a Amateur Association having its Head Office in Lod Einstein St. 26/12 Israel – represented by the President, **Mor Lizi**

Whereas

- a) **ANMB** is a Professional organization established on 14.11.1945 and acknowledged as a legal person, later it was set up as a moral entity by Decree of the Ministry of Interior dated 19.11.1998 aiming at promoting, organizing, regulating and developing dancing activities in Italy, namely in training dance teachers in any disciplines recognized in compliance with the principles stated in the Constitution and the legislation in force;
- b) **ICCDs** is an amateur Association in Israel established in 2007 and recognized by the World Dance Council Amateur League (WDC AL)

the following is hereby stated and agreed

1. The signing the present Protocol of Intentions the Parties intend to enter into an **"Alliance Agreement"** to jointly enhance both sportive dance and other genres by **"twinning"** Italy and Israel in the interest of their members;
2. with due respect for the legal autonomy of the Parties, ANMB and ICCDS, through their structures, bind themselves on a mutual consent to collaborate in organizing stages, workshops, events and performances for any kind of Dance in order to promote and enhance the study, spreading and practice of Dance – meant as a play and recreational activity and a professional study of same - both in their territories and in the WDC_AL international system;
3. The above Protocol will be automatically renewed every year. The Parties hereto may terminate the above agreement at any time by sending a registered letter or a notice by fax and/or e-mail to the other Party.
